<p><b>SELF EXCLUSION SERVICE</b></p>	<p>A license wide service dedicated to the protection of problem players. Collection and dissemination of registered player data to block new registration or close current player accounts. Inclusive of annual platform fee is €1200 towards therapy which can be provided to self-excluded players from an operators domain, through our group company <b><u>Omnia Health Group</u></b>.</p>
<p><b>REPUTATION REPORTS PER OPERATOR</b></p>	<p>Compliance review by the Licensor ensuring proper domain compliance.</p> <p>The Licensor will conduct at minimum a quarterly reputation report. At Licensor's discretion reports can be conducted on a monthly basis.</p>
